



Foreclosure Defense:

At the Moon Law Group we know that in these bleak economic times foreclosure actions have been brought against numerous homeowners. If you have been served with a foreclosure action, it is imperative that you take immediate action. In Florida you have 20 days to respond to a foreclosure complaint.

Foreclosure actions are very technical and if the lender seeking to foreclose on your property does not follow all of the rules, you might be able to use these technical deficiencies to help defend against the suit.

Furthermore, most mortgages in Florida include a restatement provision. This provision entitles you to “cure” the foreclosure by paying off what you owe at any point during the foreclosure action. Even if a substantial amount of time has elapsed since the foreclosure action was filed, you can still potentially save your house by cutting a deal with your lending institution.

Landlord – Tenant:

Are you a Florida landlord, responsible for multi-family or single family housing units? Are you struggling with tenants who are non-compliant with their lease? If so, the Moon Law Group can assist you with efficient and cost-effective eviction proceedings. Workers Compensation

Your Florida Workers' Compensation Claim:

If you have been injured while performing your job you could be eligible to receive Florida Workers' Compensation benefits. These benefits can include indemnity (lost wage) benefits, medical treatment for your job-related injury and associated benefits such as prescription drugs and reimbursement for medical mileage. You could also potentially settle your case for a lump sum cash settlement. This settlement would be in exchange for giving up your ongoing workers' compensation benefits.

The Florida Workers' Compensation system is a complex and often frustrating system of administrative laws. You should consult an experienced workers' compensation practitioner regarding the following questions:

Did my accident occur within the course and scope of my employment?

Did I report my accident in a timely fashion?

At what rate will I be compensated if I am eligible for lost wage benefits?

How long can I receive lost wage benefits?

What medical care am I entitled to?

If I am permanently disabled and unable to work what benefits am I entitled to?

Can I change doctors if I am unhappy with the treatment I am receiving?

What factors will determine how much my case is worth if I decide to work towards a settlement?

In most Florida Workers' Compensation cases an injured employee has 30 days from the date of accident to report the accident to their employer. Also, you typically need to file a claim within two years of the date of accident.
